

**VILLAGE AT LA FLORESTA**  
**QUEEN B RENAISSANCE TOUR TICKET GIVEAWAY**  
**Official Rules**

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS, RULES AND REGULATIONS APPLY. ODDS OF WINNING DEPEND ON THE NUMBER OF ELIGIBLE ENTRIES TIMELY RECEIVED. VOID WHERE PROHIBITED.**

- 1. SWEEPSTAKES PERIOD:** The Queen B Renaissance Tour Ticket Giveaway Sweepstakes (the “Sweepstakes”) will begin at 12:00 a.m. P.T. on Monday, July 31, 2023 and end at 11:59 p.m. P.T. on Thursday, August 24, 2023 (“Sweepstakes Period”).
- 2. SPONSOR:** The Sweepstakes is sponsored by Regency Centers, L.P. (“Regency” or “Sponsor”), One Independent Drive, Suite 114, Jacksonville, Florida 32202.
- 3. ELIGIBILITY:** To enter or win, Entrant must be a legal U.S. resident, who resides within 25 miles of Village at La Floresta and who is 18 years of age or older as of July 31, 2023 (the “Entrant”). Employees, officers, directors, and representatives of Regency Centers, L.P., its parent company, affiliates, subsidiaries, partners, joint venturers, licensees, service providers, advertising and sweepstakes agencies, those involved in the production, development, implementation, or handling of the Sweepstakes, or any agents acting on behalf of the above entities, as well as the immediate family members (parents, children, siblings, spouses) and/or persons living in the same household (whether related or not) of each above-mentioned individual, are NOT eligible to participate in the Sweepstakes. - 5. PRIZE & APPROXIMATE RETAIL VALUES:** There will be one prize winner. The prize winner will receive two (2) concert tickets to the Queen B Renaissance Tour and one (1) parking pass. The approximate retail value of all prizes is \$496.00.

The prize winner is solely responsible for all applicable federal, state and local taxes and/or any other fees/costs associated with the prize or receipt of the prize. Any and all guarantees and warranties for prizes are subject to the manufacturer’s and/or service providers terms and conditions, and winner agrees to look solely to such manufacturers and/or service providers for any warranty or guarantee claim. All costs and expenses not specified herein related to any prize, including but not limited to delivery, installation, service activation fees, and other expenses incurred by accepting the prize, are the sole responsibility of the winner. **6. SELECTION OF THE WINNERS:** On August 25, 2023, one (1) prize winning entry will be selected in a random drawing conducted by Regency from all eligible entries received by the way of the stated entry method. Selection of the prize-winning entry shall be made on a random basis and not based on the merits of the submission; provided that Sponsor in its sole discretion may disqualify any entry that does not conform to the requirements outlined above in the “How to Enter” section. Drawing will be conducted in accordance with the Official Rules by Sponsor, whose decisions on all matters related to the Sweepstakes are binding and final. Potential winner will be notified via email and will be instructed to provide contact information within seven (7) days or the prize will be forfeited and an alternate potential winner will be chosen.
